

INVITATION FOR BID

Gershman, Brickner & Bratton, Inc. in its capacity as Receiver for the Solid Waste Management Division of the Department of Public Works, pursuant to the Order of the United States District Court of Guam, is soliciting bids for the construction of **Landfill Operations Road and Mass Grading for Cells #1 and #2, Project No. SWMD-09-01.**

Sealed bids in duplicate will be received and time stamped at the Solid Waste Management Division – GBB Receiver Office, 2nd Floor, Solid Waste Management Building, Department of Public Works, 542 N. Marine Corps Dr., Tamuning, Guam, 96913 until 2:00 pm on January 8, 2009 local Guam time. Bids will be publicly opened and read aloud shortly afterwards at the same location.

Contract time is Two Hundred Ten (210) calendar days. All bids must be accompanied by a bid security in the amount of 15% of the total bid amount. Bid security may be a bid bond, certified check or cashier's check made payable to the Treasurer of Guam. ***A non-refundable amount of \$100.00*** is required as payment for each set of invitation for bid documents which can be obtained from the **Solid Waste Management Division – GBB Receiver Office, 2nd Floor, Solid Waste Management Building, Department of Public Works, 542 N. Marine Corps Dr., Tamuning, Guam, 96913** commencing on December 5, 2008. Payments are payable to the Treasurer of Guam and paid at any Treasurer of Guam office. Payments must reference Account No. 310060602 on the check. A receipt of payment should be obtained from the cashier before applying for the bid documents.

All Bidders are notified that the Government of Guam will affirmatively insure that in any Contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color and national origin in consideration for an award. The Government reserves the right to reject any or all bids and to waive any imperfection in the bid proposals in the interest of the Government of Guam.

A mandatory pre-bid conference will be held on December 16, 2008 at 9:00 a.m. at the Division of Highways 2nd Floor Conference Room, Department of Public Works, 542 N. Marine Corps Dr., Tamuning, Guam, 96913. A field trip to the Project site to allow prospective Bidders to familiarize themselves with the Project's site conditions will be conducted immediately after the pre-bid conference. A second field trip to the Project site to allow prospective Bidders to familiarize themselves with the Project's site conditions will be conducted at 9:00 am on December 22, 2008. It is mandatory that the Bidder attend at least one of the two field trips. A representative for a prospective Bidder is required to be present at both the pre-bid conference and at least one of the field trips to the Project site. The representative of the Bidder must be an employee of the Bidder or a person who has written authorization from the Bidder to represent him at the pre-bid conference and the field trip. The Bidder can be represented at the mandatory pre-bid conference by one of its employees via telephone. The Bidder must notify the Receiver at least two working days before the pre-bid conference they will be represented via telephone. The Bidder will be given a phone number and access code to call into the pre-bid conference. However, the mandatory field trip to the Project site must be physically attended by a representative of the Bidder. If a Bidder is not properly represented at both the mandatory pre-bid conference and at least one of the field trips they will be disqualified from submitting a bid. It is necessary that the Bidder attend both the pre-bid conference and a field trip to be adequately informed of the contract requirements and site conditions to prepare their bid.
